## 2. To declare any Interests re items on the agenda

There were no Interests declared.

# 3. To confirm minutes of the meetings held on 26yth November 2019, $3^{\rm rd}$ March and $18^{\rm th}$ August 2020

The minutes had been circulated. One small amendment was mad to the minutes of 3<sup>rd</sup> March. Cllr Thorneley then proposed that the minutes of the three meetings be accepted as accurate records of the meetings, seconded by Cllr Payne and carried, so the Chairman signed them as true copies.

## 5. To discuss Correspondence received

The Chairman was not satisfied with Norfolk County Council's responses regarding the Highways issues he had raised, so he has written to the M.P. George Freeman and has asked if he can put some pressure on Highways to deal with this. At the time of the meeting the Chairman had not received a response. During the Lock Down there was flooding on Bintree Road because the owners of the property, where the flooding had occurred, had interfered with the grups. The Chairman wrote to the Flooding Officer at Norfolk County Council and an acknowledgement has been received. The situation will be monitored.

## 6. To discuss any Planning Issues

3PL/2020/0901/F Annexe at rear of Blacksmiths Cottage, Bintree Road, change of use of holiday let to independent dwelling at Anvil Lodge, Blacksmith Cottage. The Parish Council had no objections to this application.

A letter has been received from Breckland regarding Billingford Lakes and the alleged breach of unauthorised development. The letter states that Breckland considers it is not a breach of Planning Control so the case is now closed.

#### 7. To discuss the possibility of White Gates to help with Speeding Problems

Cllr Payne is dealing with this subject and she has contacted Highways. Currently she is finding it difficult to get Highways to help with the situation but she will continue to pursue this and she has contacted Cllr Bambridge also.

8. To discuss the purchasing of new Street Lights

The Chairman has asked for another quote from T T Jones Electrical Ltd. The Parish Council agreed that something needs to be done about getting new lights as the current ones are now obsolete and it would not be possible to repair them in the future.
